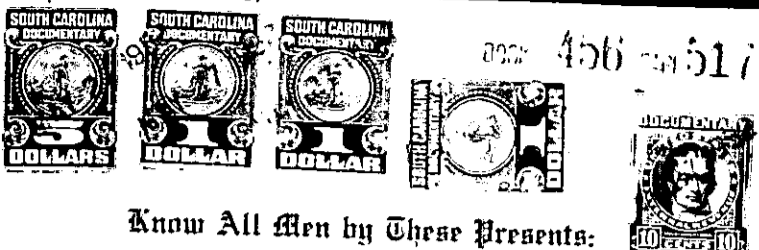

Know All Men by These Presents:

That We, WILLIAM BLACKWELL and EDNA BLACKWELL in the State aforesaid, in consideration of the sum of (\$3563.30) Three Thousand Five Hundred Sixty-Three and 30/100---DOLLARS, and assumption of Mortgage described below

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WACO F. CHILDERS, JR. and GLYNN A. LINDSEY, their heirs and assigns:

All that piece, parcel, or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 7, England Park, as per plat thereof recorded in the REC Office for Greenville County, South Carolina in Plat Book L, page 41, and having, according to said plat, the following corners and bounds, to wit:



BEGINNING at an iron pin on the Southwest side of Skyland Drive (formerly Bates Avenue), at joint corner of Lots Nos. 6 and 7, said iron pin being 225.6 feet in a Southeasterly direction from the point where the Southwest side of Skyland Drive (formerly Bates Avenue) intersects the Southeast side of Ackley Street and running thence along the line of Lots Nos. 6 and 7, S. 58-25 W. 171.7 feet to an iron pin at joint rear corner of said lots; thence S. 36-13 E. 60 feet to an iron pin at the joint rear corner Lots Nos. 7 and 8; thence along the joint line of said lots, N. 55-06 E. 170 feet to an iron pin at the joint corner of said lots on the Southwest side of Skyland Drive (formerly Bates Avenue); thence along the Southwest side of Skyland Drive (formerly Bates Avenue), N. 34-23 W. 50 feet to the beginning corner.

The herein named grantees are to pay the 1952 taxes on the above described property.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

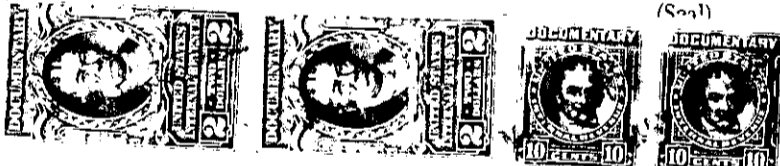
