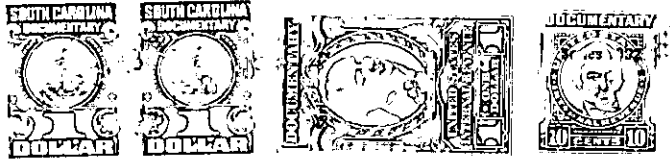
Carl B. Holland, his heirs and assigns:
