to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. L. ANDERSON, HIS HEIRS AND ASSIGNS, FOREVER:

All of my undivided one-third interest in and to all that place, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the West side of Pinckney Street and being known and designated as the Western portion of Lot No. 1, of the property of W. P. Heale, deceased; Plat of said property being recorded in Plat Book A, page 25, R.I.C. Office for Greenville County, and being more particularly described as follows:

Begin at an Iron pin on the West side of Pinckney Street at corner of lands of Alice J. Mann, which point is 30 feet northwest from joint corner of Lots Nos. 18 and 19, as shown on the above referred to Plat, and running thence S. 89-1/2° E. 131 feet, more or less, to an Iron pin on an alley; thence along said alley, N. 87-3/8° E. 40 feet, more or less, to joint rear corner of Lots Nos. 1 and 20, as shown on said Plat; thence along joint line of Lots Nos. 1 and 20, N. 39-1/2° E. 132 feet, more or less, to Iron pin on the West side of Pinckney Street; thence with Pinckney Street, S. 80-1/2° E. 40 feet, more or less, to the point of beginning.

The above interest is the same devised to me by my late Mother, Alline A. Anderson, by her Will of record in the Probate Judge's Office for Greenville County at Apartment 638, File 10; the same having been conveyed to her by the trustee herein of said dated April 7, 1932, and recorded in the R.I.C. Office for Greenville County, S. C. in Book 144, page 81.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee(s)'s Heirs and Assigns against the grantor(s) and the grantor(s)'s Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
