That I, John N. Mann in the State aforesaid, in consideration of the sum of Twenty Four Hundred & Fifty & no/100 (\$2450.00)..... DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Mildred True Wamsley, her heirs and assigns forever,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, on the north side of Palmetto Avenue and being known and designated as lot No. 17 in Block J on a plat of the subdivision known as Riverside as shown by the Plat of T. H. Foster, Surveyor, in October, 1919, recorded in Plat Book A, page 322 and 323. Said lot of land is specifically described as follows: BEGINNING at the corner of Lot No. 16 at a point 250 feet eastward from Sumter Street and running thence along Palmetto Avenue S 79-45 E. 50 feet to lot No. 18 on said Plat; thence along the joint line of Lots Nos, 17 & 18 at right angle to Palmetto Avenue 125 feet to a fifteen (15) foot alley at rear of said lot; thence along said alley N. 79-45 W. 50 feet to Lot No. 16; thence along joint line of Lots Nos. 16 & 17, 125 feet to the beginning corner; this being one of the lots conveyed to G. C. Chastain by C. A. Cann by deed dated May 29, 1945, recorded in Deed Book 276, Page 88, and conveyed to the Grantor's Grantor by G. C. Chastain by his deed dated November 29, 1947, and recorded in Deed Book 328, page 300.

ALSO all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, situate, lying and being on the north side of Palmetto Avenue, being known and designated as Lot No. 18 on Block J of a subdivision known as Riverside, Plat of which was made by P. H. Foster in October, 1909, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book A at page 322 and 323. Said lot having a frontage of 50 feet on Palmetto Avenue and extending back in parallel lines 125 feet and being the same lot of land conveyed to my Grantor by G. C. Chastain by his deed dated November 4, 1947, and recorded in the R. M. C. Office in Deed Book 326 at page 7.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

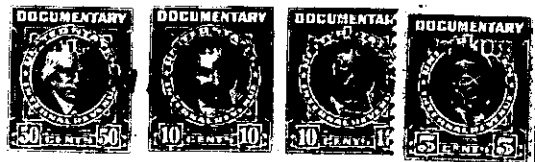
