CHARTER BY THE SECRETARY OF STATE

WHEREAS, SHELTON J. RIMER AND DOROTHY K. RIMER Box 403 Taylors, S. C. and L. A. HUTSON, JR. Box 1553, Greenville, S. C.

did on the 2nd day of June 1952 file with the Secretary of State a written Declaration, signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is RIMER TRAILER SALES

THIRD: That the principal place of business is U. S. National Highway No. 29, TAYLORS, S. C.

FOURTH: That the general nature of the business which it is proposed to do is To operate a display and sales agency for the display and sale of house trailers and house trailer accessories, and to take in trade or exchange therefor, personal property and real estate; To buy, sell, own and lease real estate and personal property; To operate and maintain a trailer court; To manufacture, build, construct, assemble or otherwise produce house trailers, their parts and accessories; To maintain a service organization furnishing to house trailer owners, or patrons, repair service and all other services designated for the protection, comfort or convenience of house trailer owners; And to do any and all other acts incident to the above business, with all of the general powers conferred upon business corporations under and by virtue of the general laws of the State of South Carolina.

FIFTH: That the amount of the capital stock is Sixty Thousand (\$60,000.00) - - - - Dollars payable \$15,000.00 cash paid in, balance payable in cash or the equivalent thereof as called for by the directors.

SIXTH: That the number of shares into which the capital stock is divided is Six Hundred (600) of the par value of One Hundred (\$100.00) - - - - - Dollars.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 26th day of May 1952 at which a majority of all stock in value being present in person or by proxy, the following were elected directors:

Shelton J. Rimer and Dorothy K. Rimer

EIGHTH: That subsequently there was elected as President, Shelton J. Rimer; as Vice-President, Edwin F. Brune; as Secretary, Mrs. Dorothy K. Rimer; as Treasurer, Mrs. Dorothy K. Rimer

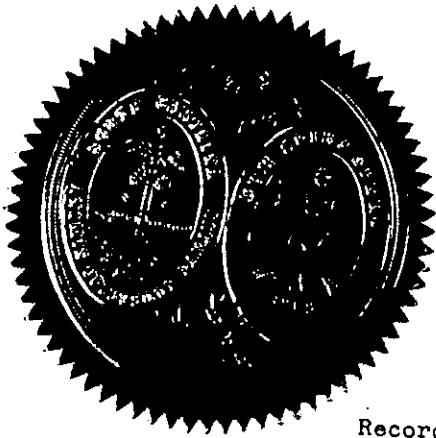
NINTH: That all requirements of Article 2, Chapter 153, Code of Laws of South Carolina, 1942, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville Piedmont

a newspaper published in the County of Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
