That I, R. E. Hughes, in consideration of the sum of - - - Six Hundred Ninety-Five and no/100 - - - DOLLARS,

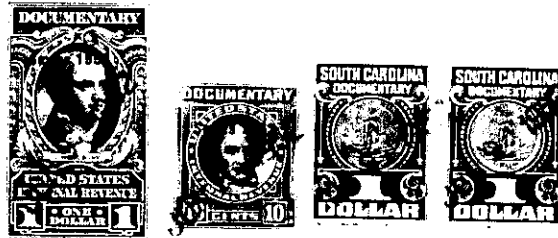

ALL that piece, parcel or lot of land in Greenville County, South Carolina, known and designated as Lot No. 62 on Courtney Circle in Casa Loma Estates, according to plat recorded in the R.M.C.
