Know All Men by These Presents:

That We, Walter W. Goldsmith and Elizabeth G. McCall in the State aforesaid, in consideration of the sum of FORTY SEVEN AND 50/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Nancy I. Harrison,

ALL that piece, parcel or lot of land located in Gantt Township, Greenville County, in subdivision off White Horse Road known as White Horse Addition according to plat made by J.C.Hill May 15, 1951 and recorded in RMC Office for Greenville County, in Book "W", page 187, said lot being No. 23 on Spears Drive and being more particularly described as follows:

BEGINNING at an iron pin on W/s Spears Drive joint front corner of lots #22 and #23 and running thence S. 60-05 W. 214.4' to an iron pin; thence S. 39-45 E. 238' to an iron pin; thence N. 12-0 E. 274.7' to an iron pin on Spears Drive; thence N. 50-30 W. 34.6' along Spears Drive to point of Beginning.

Restrictions:

- 1. Said lands shall not be sold, rented or otherwise disposed of to any person of African descent.
2. No residence is to cost less than \$4000 and no residence shall be erected on said lot nearer than 50' to the front line;
3. No outside toilets are permitted and sewage is to be disposed of by approved septic tanks.

This deed is made subject to any easements or rights of way which may have been previously given.

Grantee herein to pay taxes for the year 1952

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
