That I, W. M. Glazener, of Greenville County, in consideration of the sum of Four Hundred Fifty (\$450.00) DOLLARS,

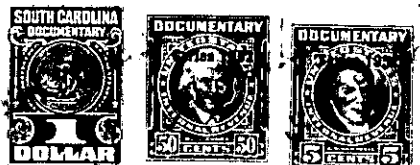
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Samuel Gus Raines, his heirs and assigns,

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, south of the Lee Road and on western side of Pinhurst Drive in "Pinhurst" subdivision, being shown and designated as Lot Number Seven (No. 7) in Section "B", on a plat of said subdivision, made by Willis, Engrs., Oct. 28, 1948; same recorded in Plat Book "S" at page 77 in R. M. C. office for Greenville County, and, according to said plat, having the following metes and bounds:

BEGINNING at a point on western side of Pinhurst Drive, joint corner with Lot No. 5 of said Section "B", which point is 186.8 feet in a southerly direction from Lee Road, and running thence S. 26-48 E. 60 feet along western side of Pinhurst Drive to point, joint front corner with Lot No. 9 of Section "B"; thence S. 62-23 W. 145.1 feet along line of Lot No. 9 to point, joint rear corner of Lots Nos. 7, 8, 9 and 10; thence in a northerly direction, along the rear line of Lot No. 8, Sixty (60) feet, to a point in line of Lot No. 6, which point is 146 feet westerly from the point of beginning; thence N. 62-23 E. 146 feet along line of Lot No. 6, and along rear lines of Lots Nos. 4 and 5, to the point of beginning.

This is the same property conveyed to me by J. B. Hall and R. E. Cox by deed dated Sept. 2, 1950, recorded in Vol. 418 at page 60 in said R.M.C. office.

This conveyance is made subject to the restrictive and protective covenants set forth in Vol. 363, page 499 in said R.M.C. office, and, further, subject to utility easements of record.
