all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 24 in in the Sunny Slope property as per plat recorded in R.M. C. Office in Plat Book "F" page 86, and being more particularly described as follows:
