Know All Men by These Presents:

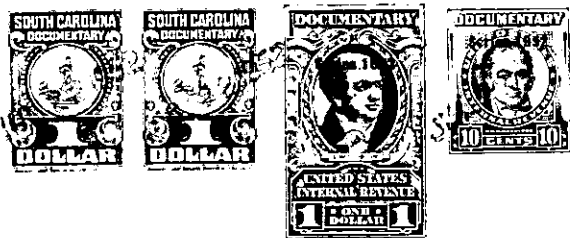
That I, C. F. Putman in the State aforesaid, in consideration of the sum of Ten Dollars and other valuable consideration
