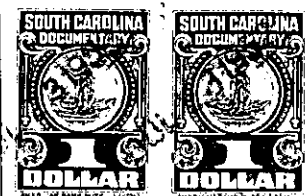

Greenville County, S. C., in deed Book 379, page 230, and further subject to utility easements of record.


TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belong-
