Know All Men by These Presents:

That David G. Traxler in the State aforesaid, in consideration of the sum of -Three Thousand Five Hundred Fifty and No/100 (\$3,550.00)- - - DOLLARS, and assumption of mortgage described below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William Franklin Aspray, his heirs and assigns, all that piece, parcel or lot of land situate, lying and being on the North side of Pacific Avenue, in the City of Greenville County of Greenville, State of South Carolina, being known and designated as Lot No. 336, Pleasant Valley, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P, page 114, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Pacific Avenue, joint front corner Lots Nos. 335 and 336 and running thence N. 0-08 W. 160 feet to an iron pin, joint rear corner Lots Nos. 335 and 336; thence S. 89-52 W. 60 feet to an iron pin, joint rear corner Lots Nos. 336 and 337; thence S. 0-08 E. 160 feet to an iron pin on the North side of Pacific Avenue; thence along the North side of Pacific Avenue N. 89-52 E. 60 feet to an iron pin, the point of beginning.

Grantee to pay 1952 taxes.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given by the grantor herein to The First National Bank of Greenville, S.
