to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John F. Westmoreland and his heirs and assigns:

All of that parcel or lot of land in Oneal Township of Greenville County, South Carolina, situated about two miles North from the City of Greer and lying on the West side of a new cut road that leads from the Ballenger Road to the Greer-Oneal Road, designated as Lot No. 5 on a plat of property made for W. Dennis Smith by H.S. Brockman, Surveyor, dated July 29, 1952, and having the following courses and distances:

BEGINNING on a stake on the western edge of said new cut road, joint front corner of Lots Nos. 3 and 5 on said plat, and runs thence with the common line of these lots N. 35.12 W. 190 feet to a stake on line of Alvin Satterfield's lot; thence S. 19.45 E. 206.5 feet to a stake (iron pin); thence S. 89.33 E. 206 feet to a stake on the West side of said new cut road; thence along the western edge of said road N. 26.10 W. 200 feet to the beginning corner.

The greater portion of the above lot is from a tract of land conveyed to me by B.A. Bennett, et al, Executors of the Estate of L.W. Jones, by deed that is on record in the R.M.C. Office for Greenville County. The northwestern corner of the tract is from a tract of land conveyed to me by Herman J. Bruce and Corrie Staton by deed which is on record in said R.M.C. Office for Greenville County.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
