That We, J. D. Hood and Grace B. Hood in the State aforesaid, in consideration of the sum of Five Hundred (\$500.00) * * * * * DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Huldon Jordan,

All that certain piece, parcel or lot of land, triangular in shape, containing 0.59 acre, more or less, and being known and designated as Lot No. One according to a plat of the property of J. D. Hood made by W. J. Riddle, Surveyor, June 12, 1952, said plat not yet recorded, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the South side of a county road on line of property now or formerly owned by Martin, and running thence S. 60-20 W. 300 ft. to an iron pin at joint rear corner of lots one and two; thence along the line of lot Number Two, N. 13-38 E. 235.5 feet to an iron pin on the South side of said county road; thence along the right-of-way of said county road S. 68-19 E. 220.1 feet to an iron pin and the beginning corner. This being a portion of the property conveyed to the grantors herein by Ruby Ragsdale Graham by deed dated the 18th day of December, 1947 and recorded in the R. M. C. Office for Greenville County in deed volume 333 at page 475.

It is the intention of the grantors herein to convey to the grantee any right, title or interest they may have in the county road.

Grantors assume and agree to pay taxes for the year 1952.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
