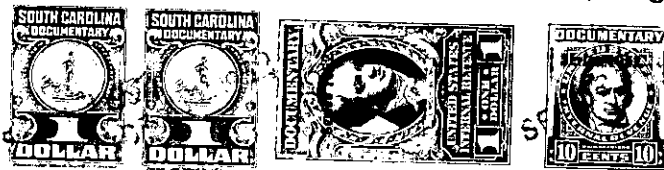

BEGINNING at an iron pin on the west side of Maco Street at joint front corner of Lots 2 and 3 and running thence with the line of Lot 2, S. 57-47 W. 156 feet to an iron pin; thence N. 10-58 W. 78.2 feet to an iron pin; thence with the line of Lot 4, N. 57-22 E. 192.8 feet to an iron pin on the west side of Maco Street; thence along the west side of Maco Street, S. 9-02 W. 99 feet to the beginning corner.
