All that lot of land in Greenville County, South Carolina, in the City of Greenville, being known and designated as Lot No. 137 as shown on revised Plat of University Heights, recorded in Plat Book BB at Page 21, and being more particularly described as follows:

BEGINNING at an iron pin on the Eastern side of Drayton Drive, the joint corner of Lots Nos. 136 and 137, and running thence with the joint line of said lots, N. 59-34 E. 192 feet to an iron pin; thence S. 29-16 E. 100 feet to an iron pin rear corner of Lot No. 138; thence with the line of said lot, S. 59-34 W. 189.5 feet to an iron pin in the Eastern side of Drayton Drive; thence with said Drive, N. 30-26 W. 100 feet to the point of beginning.

This property is conveyed subject to the following restrictions:

- 1. That this property shall be used for residential purposes only.
2. No house shall be constructed on said premises at a cost of less than \$10,000.00.
3. The lot described above shall not be recut or resubdivided.
4. Any construction on this lot shall be set back a total of 50 feet from the front lot line.
