That I, M. W. Fore in the State aforesaid, in consideration of the sum of Four Hundred Fifty & 00/100-----(\$450.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. H. Howell, his heirs and assigns forever:

ALL that piece, parcel or lot of land near the City of Greenville, State of South Carolina, being known and designated as Lot No. 103, of a subdivision known as Fore Estates, as shown by a plat thereof, dated March, 1952, made by Dalton & Neves, Engineers, and having the following metes and bounds, to-wit:

BEG INNING at an iron pin at joint corner of Lots No. 102 and 103 and running thence along the line of said Lot No. 102, N. 19-20 E. 302.8 feet to an iron pin; thence N. 88-17 E. 107.15 feet to an iron pin at back corner of Lot No. 104; thence running with the said Lot No. 104, S. 19-20 W. 341.3 feet to an iron pin on Caroline Street; thence with the said Caroline Street, N. 70-40 W. 100 feet to iron pin at point of beginning.

THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent. No residence to cost less than Seven Thousand & Five Hundred (\$7,500.00) Dollars, shall be erected on said lots, no residence shall be erected on lots fronting Polk Boulevard nearer than Thirty (30) feet to the front line on Carolina Street and Lockman Drive nearer than Forty (40) feet to the front line; no residence shall be built on any lot unless said lot has Fifty (50) feet, or more frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
