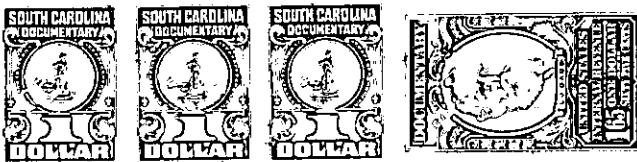

LING at an iron pin on the Northeast side of Corinne Drive, joint corner of lots 82 and 86, and running thence along the rear line of lots 86 and 85, N. 58-47 E. 204.4 feet to an iron pin; thence S. 31-13 E. 100 feet to an iron pin, joint rear corner of lots 81 and 82; thence with joint line of said lots, S. 58-47 W. 204.4 feet to an iron pin in the Northeast side of Corinne Drive; thence with said Drive, N. 31-13 W. 100 feet to the point of beginning.

This property is conveyed subject to the following restrictions:

2. No house shall be constructed on said premises at a cost of less than \$10,000.00
3. The lot described above shall not be rec'd or res'd divided
4. Any construction on this lot shall be set back a total of 50 feet from the front lot line.
