Know All Men by These Presents:

That David G. Traxler in the State aforesaid, in consideration of the sum of - - - Four Thousand Two Hundred and No/100 (\$4200.00)- - - - DOLLARS, and assumption of mortgage described below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Bernard F. Carey, his heirs and assigns, all that piece, parcel or lot of land, situate, lying and being on the South side of Pacific Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 363, Pleasant Valley, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P, page 114, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Pacific Avenue, said pin being 240 feet East of iron pin in the Southeast intersection of Pacific and Pasadena Avenues, and running thence S. 0-08 E. 160 feet to an iron pin, joint rear corner Lots Nos. 363 and 364; thence S. 89-52 W. 60 feet to an iron pin; thence N. 0-08 W. 160 feet to an iron pin on the South side of Pacific Avenue; thence along the South side of Pacific Avenue N. 89-52 E. 60 feet to an iron pin, the point of beginning.

Grantee to pay 1962 taxes.

As a part of the consideration hereof, the grantee assumes and agrees to pay, according to its terms, that certain note and mortgage given by the grantor herein to The First National Bank of Greenville, S. C., in the principal sum of \$2500.00, said mortgage being recorded in the R.M.C. Office for Greenville County, South Carolina, in Mortgage Volume 524, page 535.

This is the same property conveyed to the grantor herein by The Robert I. Woodside Company, by deed dated March 8, 1962, recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Volume 453, page 36.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
