

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the West side of Augusta Road about 3 1/2 miles from the Greenville County Court House and having according to a plat made by C. C. Jones, Engineer, on the 18th day of September, 1951, of the Property of William P. Dancy, which plat is recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book AA, at page 143, the following metes and bounds, to-wit:
