to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Everett L. Baker,

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 47 of College Heights, as shown on plat thereof prepared by Dalton S. Neves, August 1946 recorded in the R. L. C. Office for Greenville County in plat book P page 75, and having according to said plat the following notes and bounds, to-wit:

Beginning at an iron pin on the north side of Princeton Avenue, the joint corner of lots 47 & 49, and running thence with the joint line of said lots N. 33-10 ... 150 feet to an iron pin; thence N. 56-50 E. 75 feet to an iron pin corner of lot No. 46; thence with the line of said lot S. 55-10 E. 150 feet to an iron pin on the north side of Princeton Avenue; thence with the north side of said Avenue S. 56-50 ... 75 feet to the beginning corner.

Being same lot conveyed to grantor by McCall Manufacturing Company by deed dated March 17, 1952 recorded in the R. L. C. Office for Greenville County in volume 453 page 219.

This property is conveyed subject to the building restrictions applicable to College Heights.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

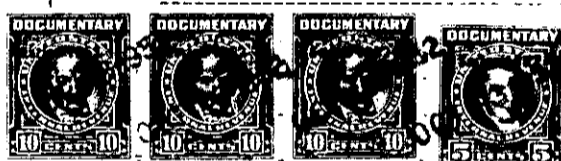
