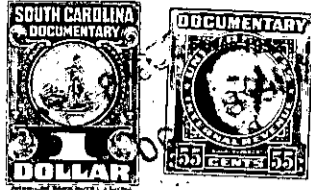

DAVIS, all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as: Lot(s) Sixty-Seven (67), Sixty-Eight (68) Sixty-Nine (69) and Sherwood Forest, as shown on a plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in plat Book Y page 23

This deed is made subject to restrictions applicable to Sherwood Forest and recorded in the R. M. C. Office for Greenville County, S. C., in deed Book 412 page 149, and further subject to utility easements of record.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the grantee  hereinabove named, and his Heirs and Assigns forever.

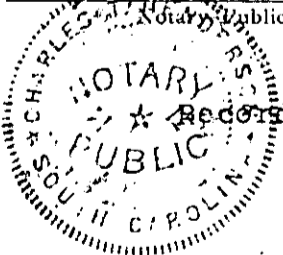
RENUNCIATION OF DOWER
