All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, on the northeast side of Griffin Drive and being known and designated as lot No. 2 of the property of Donald E. Baltz as shown on plat thereof made by E. C. Cahaly, March 1, 1951, recorded in plat book Z page 187 of the R. M. C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
