

BEGINNING at an iron pin, which iron pin is the southeast corner of Main and Oak Streets, and running thence with the southern side of Oak Street, S.68-04 E. 113.59 feet to an iron pin, corner of property of Morris & McKoy; thence with the line of property of Morris & McKoy, S.18-30 E.40.1 feet to a point in the southern face of a brick wall; thence along the southern edge of said brick wall, N.68-04 W. 114.42 feet to a point, the southwest corner of said brick wall in line of Main Street; thence with North Main Street, N.19-51E.40 feet to the point of beginning, subject, however, to the rights of Carpenter Brothers Drug Company, Inc., its successors and assigns to tie to the southern face of the southern brick wall above described.

BEGINNING At an iron pin at the southwest corner of the intersection of North Brown and Oak Streets, and running thence with the West side of Brown Street, S. 19-39W. 39.55 feet to an iron pin at corner of other property of grantor; thence N. 66-26 W. along the northern edge of a brick wall 73.6 feet to a point; thence N. 68-04 W. along the southern edge of a brick wall 35.58 feet to a point in the southern edge of said wall, thence N. 18-30 E. 40.1 feet to a point on the south side of Oak Street, said point being in the northern edge of a brick wall; thence with the northern edge of said wall and with the south side of Oak Street S. 68-04 E. 109 feet to an iron pin, the beginning corner; subject, however, to the rights of A.
