to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Barnett Long and Alice Long, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 1 of a subdivision known as Section "C", of Englewood Estates, as shown by a Plat thereof, dated December, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "BB", at Page 13.

BEGINNING at an iron pin on Fairfield Road at the intersection of Sioux Drive and running thence with Fairfield Road S. 68-31 W. 100 feet to an iron pin in the line of Lot No. 2; thence with the line of Lot No. 2, S. 40-07 E. 294.8 feet to an iron pin; thence N. 29-00 E. 210.7 feet to an iron pin on Sioux Drive; thence with Sioux Drive, N. 68-40 W. 213.7 feet to the point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than 50 feet to the street.
3. No temporary house is to be erected on said lot.
