All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot Twenty-five (25) on plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book "AA", page 187, and having according to said plat the following courses and distances, to wit:

BEGINNING at a point on Waston Street joint front corner of Lots 24 and 25; thence along the line of Lot No. 24 N. 47-0 W. 122.7 feet to point on rear line of Lot No. 49; thence along the rear line of Lot No. 49 S. 43-0 W. 23 feet to joint corner of Lots 48 and 49; thence along the rear line of Lot No. 48 S. 4-16 W. 65.1 feet to corner of Lot No. 26; thence along the line of Lot No. 26 S. 47-0 E. 85 feet to Waston Street; thence along Waston Street N. 43-0 E. 70 feet to the beginning corner.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

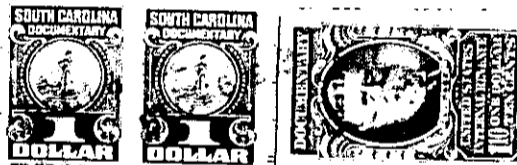
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.
