McKinney and W. Roscoe Jones, their heirs and assigns;

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot thirty-one (31) on plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book "AA", page 187, and having according to said plat the following courses and distances, to wit:

Beginning at a point on Waston Street, joint corner of Lots 30 and 31 and running thence along the line of Lot No. 30 N. 47-0 W. 122.7 feet to rear line of Lot No. 42; thence along the rear lines of lots 42 and 41 S. 43-0 W. 60 feet to corner of Lot No. 32; thence along the line of Lot No. 32 S. 47-0 E. 122.7 feet to Waston Street; thence along Waston Street N. 43-0 E. 60 feet to the beginning corner.

The lot above described is conveyed subject (1) to the covenants and restrictions recorded in the R.M.C. Office for Greenville County in Deed Book 444, page 498, which are made a part hereof as fully as if set out herein, (2) to the public utility easement granted to the Duke Power Company, which is recorded in said R.M.C. Office in Deed Book 445, page 235, and (3) to sewer line right of way granted to the City of Greenville on August 22, 1952 and recorded in Deed Book 461, page 548, R.M.C. Office for Greenville County.

The lot herein conveyed constitutes a portion of the property conveyed to me by R. M. Caine, by deed dated March 10, 1951, and recorded in the R.M.C. Office for Greenville County in Deed Book 430, page 372.
