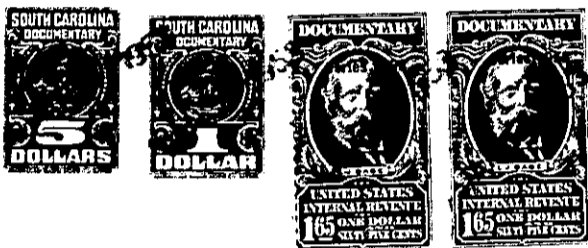
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Shirley Jones:-

All that certain piece, parcel or lot of land lying and being in Austin Township, Greenville County, State of South Carolina, in the Town of Simpsonville on the west side of an old stage road (now North Maple Street) adjoining lands of S. T. Pollard, J. E. Jones and others. It begins at the corner of a lot formerly known as lot # 6 and runs thence N. 16 1/2 W. 151 ft. to a stone; thence along the line of property now or formerly owned by Mrs. Cox a distance of 50 ft. to a stake; thence in an easterly direction 151 ft. to a stake in road at a point 50 ft. from the starting point; thence up the said road 50 ft. to the beginning corner and being the same lot conveyed to Howard D.
