to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Quentin T. Gilbert, his heirs and assigns forever:

All that certain tract of land in Greenville County, State of South Carolina, in Butler Township, containing 36 acres, more or less, according to plat of the property of Tom Radden, made by W. J. Riddle, February 1940, recorded in Plat Book 3 at Page 7, in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake at the corner of property of Larkin Durham, which stake is at the intersection of two branches and running thence with branch S. 42-40 E. 225 feet to a point in center of bridge crossing said branch; thence with center of Pelham Road, N. 36-20 W. 125 feet; thence continuing along Pelham Road, the following courses and distances, S. 26-29 W. 20 feet, S. 22-39 W. 40 feet, S. 16-28 W. 40 feet, S. 26-08 W. 454.7 feet to stake in center of Pelham Road; at a point where a County Road intersects said Pelham Road, which point is the corner of a tract of land conveyed to E.
