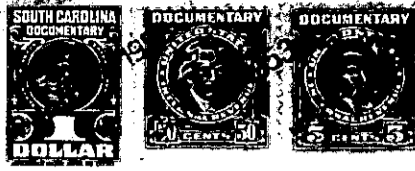

Beginning at a point on the West side of Holland Street at a stake at the corner of lot 31 and running S. 21-05 E., 320 feet along the said street to a stake at the corner of lots 43 and 44; thence N. 72-05 E., 350 feet to a stake at the joint corners of lots 31 and 32; thence N. 68-55 E., 277 feet to the beginning corner.
