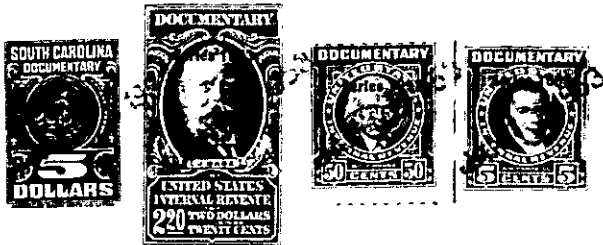
ELLIE FARNSWORTH, Know All Men by These Presents: R.M.C.

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said O. L. Jones, his heirs and assigns forever.

All that piece parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Tract No. 32 of Oakvale Farms, according to a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book M, page 15, and being more fully described as follows:

BEGINNING at an iron pin, joint corner of Tracts Nos. 31 and 32, on public road, and running thence with joint line of said lots S. 30-02 W. 347.6 feet to joint corner of Tracts Nos. 21, 32 and 35; thence with rear line of Tract No. 32 and side line of Tract No. 35, N. 61-44 W. 252.3 feet to joint rear corner of Tracts Nos. 32 and 33; thence along joint line of Tracts Nos. 32 and 33, N. 30-02 E. 738.3 feet to an iron pin on public road, joint corner of Tracts Nos. 32 and 33; and thence along public road, S. 84-52 E. 278.1 feet to the point of beginning, being the same conveyed to me by O. L. Jones by deed dated May 2, 1952, and recorded in the R. M. C. Office for Greenville County in Book 455, page 543.
