Greer, in consideration of the sum of One (\$1.00) and division of land to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee Daniel M. Greer and his heirs and assigns:

All that certain parcel or lot of land containing Two (2) Acres, more or less, situated on the Rutherford Road, near Jubilee Church, about four miles north from Taylors, in Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 1 of the property of D. M. Greer's Estate, according to survey and plat thereof by H. S. Brockman, Surveyor, dated November 20, 1950, and having the following courses and distances, to wit: Beginning at a point in the road, corner of Lot No. 2, and running thence along the line of Lot No. 2, N. 47.45 W. 792 feet to stake on line of Lot No. 7; thence along the line of Lot No. 7 and 8, S. 42.00 W. 110 feet to stake on line of other property of Daniel M. Greer; thence along said line, S. 47.45 E. 792 feet to stake near road; thence along said road, N. 42.00 E. 110 feet to the beginning corner.
