Will Pepper -- his heirs and assigns all that piece, parcel or Lot of Land in Gantt Township County of Greenville, State of South Carolina and having the following metes and bounds. Beginning at an Iron pin at the joint rear corner of the Blassingame and Sherman Lots and running along the Moses Dillard Line S 54-02 E 208 Feet to an Iron pin on the Zet Smith property line thence along said line S 33-55 W 219.4 feet to an Iron pin thence S 56-35 E 107 feet to an Iron pin on the Allen Miles Line thence N 34-00 E 210 feet along the back line of the Blassingame Lot to the point of beginning.

This deed is made to correct the description in a certain warranty deed made by the parties of the first part to the party of the second part dated 6/28/47 and recorded in the R. M. C. office for Greenville County at 316-396 in that the party of the second part herein agreed by separate instrument recorded, that the metes and bounds are to conform to a plat of the Zet Smith property drawn by J. M. Richardson R.L.S. April 1951 and recorded in the R. M. C. office for Greenville County.

Said plat being recorded in Book F F, at Pages 34 and 35.
