Beginning at an iron pin at the joint front corner of Leo Sherman Lot and running N. 56-35 W. 210' to an iron pin; thence S. 34-00 W. 210' to an iron pin on the Allen Miles line; thence S. 56-35 E. 210' to an iron pin on Smith Street; thence N. 34-00 E. 210' to the point of beginning.

Office for Greenville County at 282-68 in that the party of the second part herein agreed by separate instrument recorded, that the metes and bounds are to conform to a plat of the Zet Smith property drawn by J.
