KNOW ALL MEN BY THESE PRESENTS. That I, T.D. Bennett (Widower )  
in the State aforesaid, in consideration of the sum of  
Two Thousand Four Hundred & No/100 ( \$ 2400.00 ) Dollars  
to Me  
by L.C. Pressley and Julia Peebles Pressley  
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said L.C. Pressley and Julia Peebles  
Pressley their heirs and assigns forever ;

all that piece, parcel or lot of land in Grove Township, Greenville  
County, State of South Carolina , One lot in Rehobeth School Distraict, lying  
adjacent to property now or formerly owned by Nancy Williams and  
being situated near Rehobeth Baptist Church .

" Beginning at stake on ditch cut by  
Greenville County to drain surface treated Piedmont- Pelzer Road  
being being intersection of ditch and terrace, thence along said  
terrace in a South east direction 289 feet to intersection with  
another ditch, thence along latter ditch 125 feet to where ditch  
enters into dirt road owned by Furman A Billingsley and Haskell  
M & Mildred George, thence along said road 74 feet to ditch, thence  
with meandering of said ditch 296 feet to point of origin, said  
lot fronts on land now or formerly owned by Nancy Williams."

deed by Haskell M and Mildred W George on the 28th day of November

ALSO ; All that piece, parcel or lot of  
land in Grove Township, Greenville County, State of South Carolina  
one lot in Rehobeth School district, lying adjacent to proprty  
now or formerly owned by Nancy Williams and being situated near  
Rehobeth Baptist Church.

" Begining at joint corner Furam A and  
Ruby P Billingsley, Haskell M & Mildred W George anf grantor thence  
in a Northern direction 112 feet to Stone X 3, thence in a Western  
direction 189 feet 8 inches to Terrace line of Haskell M and Mildred  
W George; thence with meandering of terrace 197 feet 3 inches to  
center of road; thence in a Southern direction 100 feet to begin-  
ing corner, containing one-half acre ( 1/2 ) more or less. "
