to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said David G. Traxler, his heirs and assigns, all that piece, parcel or lot of land, situated, lying and being on the Northerly side of Arlington Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 25, Block E, Paris Heights, as per plat thereof recorded in the R. L. C. Office for Greenville County, South Carolina, in Plat Book Y, page 65, and having, according to said plat, the following more and bounds, to wit:

BEGINNING at an iron pin on the Northerly side of Arlington Road, said pin being 330 feet in an Easterly direction from iron pin in the Northeast intersection of Pisgah Drive and Arlington Road and running thence along the line of lots Nos. 24 and 25, Block E, N. 17-30 W. 180.6 feet to an iron pin; thence N. 86-58 E. 82.5 feet to an iron pin; thence S. 17-30 E. 160 feet to an iron pin, joint front corner Lots Nos. 25 and 26, on the Northerly side of Arlington Road; thence along the Northerly side of Arlington Road S. 72-30 W. 80 feet to an iron pin, the point of beginning.
