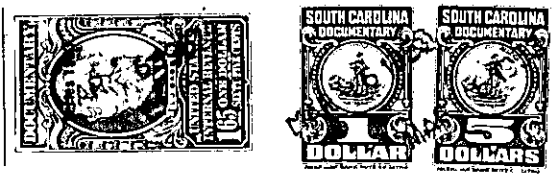

Know All Men by These Presents:

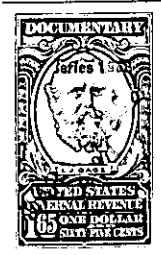

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. L. Wakefield, his heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being in the City of Greenville on the Northwestern side of Alpine Way, and being known and designated as Lot No. 2 of property of C. A. Harvin, Jr., and J. K. Buff as shown on Plat thereof recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book CC, page 143, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Alpine Way, joint front corner of Lots Nos. 1 and 2, and running thence with the line of Lot No. 1, N. 50-41 W. 172 feet to an iron pin in the line of property now or formerly belonging to Stone; thence with Stone line, S. 38-31 W. 75 feet to an iron pin, joint rear corner of Lots Nos. 2 and 3; thence with the line of Lot No. 3, S. 50-41 E. 171 feet to an iron pin on the Northwestern side of Alpine Way; thence with the Northwestern side of Alpine Way, N. 39-19 E. 75 feet to the beginning corner.
