ALL that piece, parcel or lot of land in Greenville County, Greenville Township, State of South Carolina, located on Douglass Avenue and being a portion of Lot No. 75 as shown on plat recorded in Plat Book "F" at page 126 in the R.M.C. Office for Greenville County, South Carolina, and also shown upon the revised plat of the property of E. L. Smith and L. E. Smith recorded in the R.M.C. Office for said County in Plat Book "FF" at page 40 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Douglass Avenue, said pin being at the joint front corner of Lots 74 and 75 and running thence along Douglass Avenue, N. 59-00 W. 50 feet to an iron pin; thence running N. 31-00 E. 150 feet to an iron pin; thence S. 59-00 E. 50 feet to an iron pin; thence S. 31-00 W. 150 feet to an iron pin on Douglass Avenue; the beginning corner.
