Know All Men by These Presents:

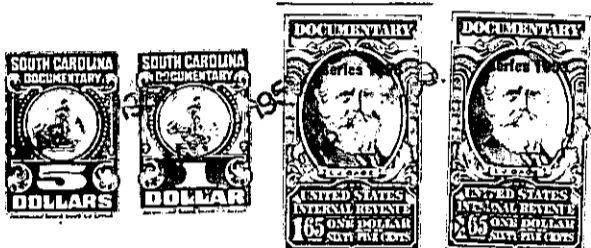
That I, W. W. Wilkins in consideration of the sum of Three Thousand (\$3,000.00) - in the State aforesaid, DOLLARS,

RENUNCIATION OF DOWER

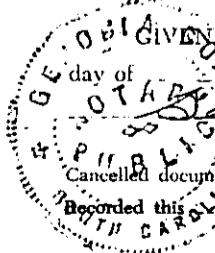
