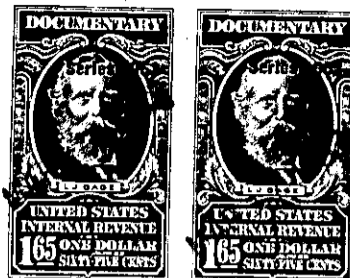

All that lot of land situate on west side of Friartuck Road, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 46 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book "BB", at Pages 30 and 31, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Friartuck Road, joint corner of Lots 45 and 46 and running thence along the rear line of Lots 44 and 45, S. 57-41 W. 155.7 feet to an iron pin; thence N. 12-07 W. 157.7 feet to an iron pin; thence with the line of Lot 47, N. 89-52 E. 149.8 feet to an iron pin on the west side of Friartuck Road; thence with the curve of Friartuck Road (the chord being S. 11-43 E. 73 feet) to the beginning corner.

BEGINNING at an iron pin on the southeast side of Friartuck Road, at joint front corner of Lots 62 and 63 and running thence with the line of Lot 62, S. 48-56 E. 153.9 feet to an iron pin; thence S. 51-37 W. 76.3 feet to an iron pin; thence S. 20-48 E. 30 feet to an iron pin; thence with the line of Lot 65, N. 87-17 W. 181.6 feet to an iron pin on the east side of Friartuck Road; thence with the curve of Friartuck Road (the chord being N. 30-21 E. 129 feet) to an iron pin; thence continuing with Friartuck Road, N. 41-04 E. 75 feet to the beginning corner.
