Know All Men by These Presents:

That we, Lide L. Richbourg and Lila M. Richbourg, in consideration of the sum of Ten & no/100 (\$10.00) and other valuable consideration, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said MRS. ELIZABETH B. RICKETTS:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot Number Twenty-Nine (29), as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is of record in the R. M. C. Office for said County and State in Plat Book "EE", at pages 2 and 3, reference to which plat is hereby made, said lot of land being described by metes and bounds as follows, to-wit:

BEGINNING at an iron pin on the Northeastern side of Richbourg Road as shown on said plat at the corner common to Lots 29 and 30, and running thence North 49-38 East along the dividing line between Lots 29 and 30, two hundred twenty-five and five-tenths (225.5) feet to an iron pin; thence North 54-15 West, thirty-seven (37) feet to an iron pin; thence North 47-38 West, one hundred thirteen (113) feet to an iron pin; thence South 43-16 West one hundred eighty-two and eight-tenths (182.8) feet to an iron pin; thence following a curved line as shown on said plat, the chord of which curve runs South 1-37 East thirty-five and four-tenths (35.4) feet to an iron pin on the Northeastern side of Richbourg Road; thence along the Northeastern line of Richbourg Road South 41-03 East one hundred (100) feet to the place of beginning.

This property is subject to the restrictions and reservations set out in an instrument of writing dated January 20, 1953, and recorded in the R. M. C. Office for said County and State in Deed Book 470 at page 369, reference to which is hereby expressly made as a part of this conveyance, and is subject to the following additional restrictions: "All tanks, barrels and containers for fuel oil shall be placed below the surface of the ground or concealed".

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
