All that certain piece, parcel, lot or tract of land lying, situate and being in Butler Township, in the City of Greenville, State and County aforesaid, on the East side of Boland Street, known and designated as lot No. 2 of plat of Bessie Boland property, made by C. O. Riddle, Surveyor, February 19, 1953, and having the following metes and bounds:

BEGINNING at an iron pin on the East side of said Boland Street, joint front corners of lots Nos. 1 and 2, and running thence with joint line of said lots N. 51-1/3 E. 161.2 feet to other property of grantor; thence N. 22-22 W. 50 feet to joint rear corner of lots Nos. 2 and 3, said plat; thence with joint line said lots Nos. 2 and 3 S. 60-08 W. 159.2 feet to iron pin on Boland Street; thence with Boland Street approximately S. 23-02 E. 65 feet to iron pin, being the point of beginning.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
