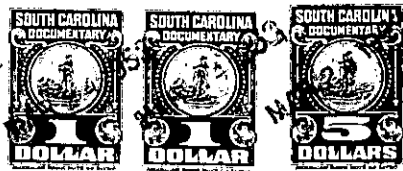

Know All Men by These Presents:

That I, Donald E. Baltz in the State aforesaid, in consideration of the sum of Thirty-five Hundred (\$3500.00) - - - DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said David W. Barnett,

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 12 on plat of property of Donald E. Baltz recorded in plat book Y page 46 of the R. M. C. Office for Greenville County, and having according to a recent survey made by R. W. Dalton the following metes and bounds, to-wit:

Beginning at an iron pin on the southwest side of Don Drive, the front joint corner of lots Nos. 12 & 13 and running thence with the joint line of said lots S. 32-07 W. 150 feet to an iron pin corner of lot No. 26; thence with the rear line of lot No. 26 N. 57-53 W. 75 feet to an iron pin corner of lot No. 11; thence with the line of said lot N. 32-07 E. 150 feet to an iron pin on the southwest side of Don Drive; thence with the southwest side of Don Drive S. 57-53 E. 75 feet to the beginning corner.

Being a portion of the property conveyed to grantor by Lucy W. Gifford by deed dated January 31, 1951 recorded in deed volume 428 page 170 of the R. M. C. Office for Greenville County.

The grantee assumes and agrees to pay that certain mortgage given by Donald E. Baltz to W. W. Wilkins in the amount of \$5,000 dated October 23, 1952 recorded in mortgage volume 543 page 370.
