W. Fore, his heirs and assigns, forever.

All that lot of land on the Southeast side of the Old Grove Road in Gañtt Township near the City of Greenville, in Greenville County, State of South Carolina, shown as Lot No. 31, Section 2, on plat of Fresh Meadow Farms, made by Madison H. Woodward, May 21, 1945, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", at Page 61, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING AT AN IRON pin on the Southeast edge of the Old Grove Road, joint front corner of Lots 31 and 32 and running thence with the line of Lot 32, S. 44-30 E. 314.2 feet to an iron pin; thence with the line of Lot 35, N. 45-30 E. 40.8 feet to an iron pin; thence with the rear line of Lots 7 and 8, N. 24-05 W. 134 feet to an iron pin; thence with the line of Lots 3 and 6, N. 39-45 W. 240.3 feet to an iron pin on the southeast side of the Old Grove Road; thence along the southeast side of the Old Grove Road, S. 17-55 W. 123.2 feet to the beginning corner.

This property is conveyed subject to building restrictions applicable to Section 1 of Fresh Meadow Farms, which are of record in the R. M. C. Office for Greenville County, S. C. in Deed Book 289, Page 8, except that No. 3 of said restrictions shall not be applicable to this property.
