in consideration of the sum of One thousand, four hundred and no/100 (\$1,400.00)---- DOLLARS,

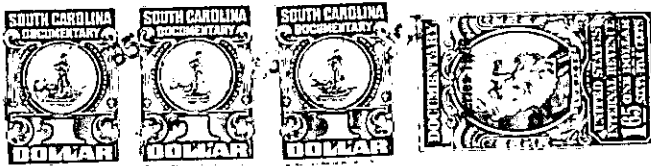

HACK E. HENRY, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as the Southern one-half of Lot Number 37 of the Property of Central Development Corporation according to a plat of record in the R. M. C. Office for Greenville County in Plat Book BB at Pages 22-23, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Alpine Way at the joint front corner of Lots 37 and 38 and running thence S 50-41 E 175 feet to a point at the joint rear corner of Lots 37 and 38; thence N 39-19 E 37.5 feet to a point in the rear line of Lot 37, said point being 37.5 feet Southwest of the joint rear corner of Lots 36 and 37; thence N 50-41 W 175 feet to a point on the Southeastern side of Alpine Way, said point being 37.5 feet Southwest of the joint front corner of Lots 36 and 37; thence with the Southeastern side of Alpine Way S 39-19 W 37.5 feet to the point of beginning.
