Know All Men by These Presents:

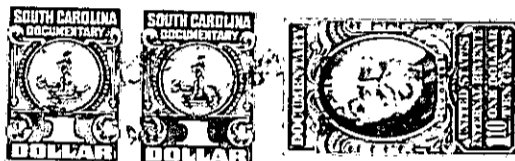

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantees, H.K. Brezeale and J.B. Brezeale and their heirs and assigns forever:

All that certain parcel or lot of land situated on the North side of the Dual-lane Highway No. 29 and the West side of Ashmore Street in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 8 of the Property of Geanie L. Caldwell, according to survey and plat thereof by H.L. Dunahoo, Surveyor, dated October 24, 1949, recorded in Plat Book "X", page 1, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

Beginning at a stake on the West side of Ashmore Street at right-of-way line of highway on the north side, and running thence along the west side of Ashmore street, N. 10.00 W. 100 feet to corner of Lot No. 9; thence along line of same, S. 78.00 W. 331 feet to stake on branch; thence S. 70.30 W. 44 feet to stake in line of Groce or Suttles Property; thence along line of same, S. 88.00 E. 366 feet to iron pin on right-of-way line of highway; thence along said line 41 feet to the beginning corner.
