Know All Men by These Presents:

That WE, Robert Clyde Wilkie and Sarah W. Wilkie in the State aforesaid, in consideration of the sum of Sixteen Hundred Thirty-five and 05/100 (\$1635.05) - DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. Eugene Trammell,

All that piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, on the northern side of Paris Mountain Avenue, near the city of Greenville, being shown as Lot No. 53 on plat of the Ferry property, recorded in the R. F. C. Office for Greenville County in plat book "C" at page 45, and described as follows:

Beginning at a stake on the northern side of Paris Mountain Avenue, 60 feet east from Newland Avenue at corner of lot No. 52, and running thence with the line of said lot N. 5-50 E. 100.5 feet to a stake; thence continuing with the line of said lot N. 3-13 E. 50 feet to a stake in line of lot No. 50; thence with the line of said lot N. 37-45 E. 62.5 feet to a stake at corner of lot No. 54; thence with line of said lot S. 5-50 E. 140.2 feet to a stake on Paris Mountain Avenue; thence with the northern side of Paris Mountain Avenue; S. 84-23 E. 65 feet to the beginning; corner.

The grantee herein assumes and agrees to pay the balance of \$5,364.95 on that certain mortgage given by Herman Irice Wigley to the Canal Insurance Company dated December 3, 1947 recorded in mortgage volume 374 at page 131 of the R.
