Claud H. Leach, his heirs and assigns forever.

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, School District 160, formerly 6-E, being known and designated as Lot No. 41 of a subdivision known as Cordell Subdivision No. 10 according to a plat thereof made by C. C. Jones in December, 1952 and recorded in the R. M. C. office for Greenville County in Plat Book BB, at page 84, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Bent Bridge Road at the corner of Lot No. 40, which point is 165 feet southwest of the intersection of Stokes Street, and running thence along the north side of Bent Bridge Road, S. 60-40 W. 70 feet to an iron pin at the corner of Lot No. 42; thence along the line of that lot, N. 24-00 W. 248 feet to an iron pin at the rear corner of said lot in the line of Lot No. 37; thence along the line of that lot, N. 66-24 E. 69.5 feet to an iron pin at the rear corner of Lot 40; thence along the line of that lot, S. 24-20 E. 229.2 feet to the beginning corner; being a portion of the property conveyed to grantor corporation by Louise Earle and India E. Pepper by deed dated Sept. 25, 1952 and recorded in the R. M. C. office for Greenville County in Vol. 463, at page 503.

The above described lot is shown on the Township Tax Map at Sheet 240, Block 1, Lot 41, and the grantee is to pay taxes for the year 1953, said taxes having been pro-rated as of this date.
