Know All Men by These Presents:

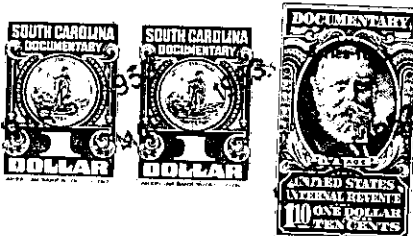
That L. C. b. Henderson in consideration of the sum of Six Hundred and No/100 (\$600.00) in the State aforesaid, DOLLARS,

All those three certain lots of land in Chick Springs Township, Greenville County, State of South Carolina, known and designated as lots Nos. 16, 17, and 18 of Block "B" as shown on plat of Buena Vista Subdivision, which is duly recorded in the R. M. C. Office for Greenville County in Plat book "W" at pages 11 and 29, having according to said plat the following metes and bounds to-wit:

Beginning at an iron pin on the northwest side of Mayflower Street, at the joint front corner of lots Nos. 15 and 16 of Block B, and running thence with line of Lot No. 15 N. 47-08 W. 150 feet to iron pin; thence S. 42-52 W. 105 feet to iron pin, corner of lot No. 19; thence with line of lot No. 19, S. 47-08 E. 150 feet to iron pin on Mayflower Street; thence with the Northwestern side of Mayflower Street, N. 42-52 E. 105 feet to the beginning corner.
