C., lying on the West side of Poplar Road (formerly New Pelham Road) and being known as lots one and two on a plat of property made for the grantor by H. S. Brockman Dec. 15, 1952, and having the following metes and bounds according to said plat.

Beginning at an old iron pin on the West side of said road and running N. 89-03 W., 167 feet along the property of Charles E.
